I am fully aware and acknowledge that horse sports and the Competition involved inherent dangerous risks of accident, loss and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death.

* I Agree to hold harmless and release BEGI, BEGI Games Competition and Virginia Horse Center from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of BEGI or the Competition.

* I Agree to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the BEGI or the Competition.
